3. **TABLES:** Tables measure 8 feet. Tables and chairs are provided. Please provide your own table covers. Tablecloths which overhang tables must be flameproof by law. No shelves or displays taller than 72" allowed.
4. All boxes, merchandise, etc. must be on or under your table. Nothing is allowed in the isles.
5. **EXHIBIT CONTENTS:** All fields of antique and collectible toys are welcome. Show management reserves the right to be the sole judges as to the suitability of exhibitor's merchandise.
